PROCESSION DECLARATION FORM FOR ALL ENTRIES IN

Bridgwater, Burnham on Sea, Weston-Super-Mare, North Petherton, Shepton Mallet,
Wells, Glastonbury and Midsomer Norton Carnivals.

This form must be completed, signed and handed in on arrival at the assembly area at Bridgwater, at the first SCFGCA carnival which you enter.

Bridgwater assembly areas:

Parkway: Mounted entries in classes 1 to 8. Knowle/Trevor Road: Masqueraders in classes 7 to 13

1. CONDITIONS OF ENTRY

The full Conditions of Entry were available when you made your initial entry and can be found at <https://www.somersetcountycarnivals.com/entries/>

2. GAPS PROCEDURE

This procedure has been introduced to avoid gaps in the procession which could cause safety issues for clubs and members of the public.

CONDITIONS:

- a) During the procession, there must be no more than a 30 metre (100ft) gap between entries. This will allow judges and the public to gain the best impression of your entry.
- b) Throughout the procession a member of your ground crew must be stationed at the rear of the entry to observe the entry following. If a gap starts to materialise, or the entry behind stops, your driver must be advised to slow down, or stop, to prevent a gap forming. Your Road Marshal must be made aware of the situation so that the above procedure can be implemented.

STATEMENT

We declare that:-

1. We have read and will comply with the Conditions of Entry and the Gaps Procedure.
2. We hold a current and valid VSO licence (if required to do so), or that we comply with Motor Vehicle (Construction & Use) Regulations.
3. We have all necessary and appropriate insurance cover, our vehicles are taxed and have an MOT (if required).
4. Our road crew will be fully briefed prior to commencement of the procession.
5. All necessary Risk Assessments have been completed.
6. A Safeguarding (Chaperone) policy is in place (if applicable).
7. If applicable, special effects (i.e. pyrotechnics/flame/gas propelled) have been authorised.
8. Where a mobility scooter, electric scooter, golf buggy, segway or any type of vehicle forms part of our entry, the vehicle and drivers are entitled to be on the highway and have appropriate insurance cover.
9. We hold copies of items listed on page 25 of the VSO Carnival Handbook.
